Dear Mr. Redmiles

I met you Wednesday at the Fremont County Courthouse. Christine Korn later indicated that you had scheduled a meeting with Ms. Korn and me on February 15, 2005, at 10 am. I would like to verify if this is true.

I would also like to invite you to the seminar I am presenting in Denver on February 4, 5, 6. This intensive seminar covers state and Federal law governing child protection, and will go a long way to providing you with the tools you need to effectively defend April Fields. A highly experienced and prestigious Massachusetts attorney who attended this seminar in Florida last October stated he learned more in three days than he learned in three years of law school. I would highly recommend that you cancel whatever you may have planned on that weekend and attend. If you are interested, Christine Korn is sponsoring it and she can provide you with the details. I will interpret your attendance or lack thereof as the indicator of your intent to provide April with vigorous representation. I've already seen your ability. You are out of your element and you need to know what's really going on if you want to provide effective assistance of counsel to all of your clients.

As you know, I observed what happened in April's hearing. What I saw gave me great concern. I don't know if you are aware of this or not, but if Meconi gets his summary judgement OR his adjudication at trial, the next step will be a precipitous permanency plan for adoption and a motion for summary judgement to terminate her parental rights as provided in the Colorado Children's Code.

My expert analysis of this case indicates only two things which can resolve this issue: Flawlessly good, uncompromising lawyering and/or bad press. Up until now, Christine has kept me on a tight rein. After what I saw in court on Wednesday, I've chewed through the bit and Christine no longer holds my reins. Just so you are duly informed and not taken by surprise, regardless of what you choose to do, *People for Equal Protection* (PEP) cameras are on this case. They are in the family household, and covering all the players. I may or may not be present, but PEP cameras are. I will report and broadcast nationally what PEP cameras and observers see. PEP will broadcast this compelling story nationwide.

I hope to see you at the seminar. Also, Christine advised me that you are seeking assistance with research for pleadings. I cannot assist unless you send me your request in writing on your letterhead. This is merely to dot my i's and cross my t's for my protection against further malicious UPL charges by Meconi.

If you do **not** attend all three days of my seminar, please understand that my consultation services will **no longer** be free to you. You will have to pay \$65/hr for my consultation services if you utilize my assistance. I respected your choice not to avail yourself of my free expertise when they would have been most effective. Now, things are really screwed up, (*worse than I have ever seen in 14 years of research, I might add*), which I predicted and which was totally preventable. Time is of the essence, Mr. Redmiles. It may already be too late. I hope you understand how serious this really is.

Then, again, perhaps you do. I, better than most, understand the vulnerability of a parent with young children who is potentially in Meconi's gun sights. After all, Meconi is using Ashley, an innocent child, to make war on me and Christine. This makes for very ugly press for anyone who

won't fight that outrage. This saga has the interest of several mainstream media outlets in addition to PEP. I spent two hours interviewing with one of them after my trial on Tuesday. I've also provided video footage to a Denver network affiliate at their request.

If needed, the protection of your family and your profession can be arranged, should you chose to vigorously fight Meconi and/or hire me. I merely advise anyone who is already involved, the battle lines have been drawn, the big guns are placed and the battle is engaged. This battle will most likely determine the outcome of the war. There's no getting out safely any more. Pick a side and staunchly defend it. If I know Meconi, (and trust me - after 8 years I do) anyone caught in the middle or fleeing the battlefield will be mowed down in the fray. I didn't write the rules of engagement, but I understand them. I can show no quarter, either. There is no fence to sit on any more. If you are not fighting for April all the way with big brass balls, you are against her. If you withdraw, you will have always been against her. You can't string any of us along any longer, and I will faithfully report what I document.

You get to go home to your kids every day. Look at them and reflect on how precious they are to you and how you would feel if they were taken from you based on lies and you could see it was being set up so you could never get them back. What would you do? I know it's not easy to be the champion for the aggrieved underdog against powerful forces with deep pockets. I've taken the hits for years in that role. I understand that some are just not champion material.

Resources aside, Meconi's influence extends to the boundaries of Fremont County, perhaps a little beyond. He influences mostly politics and the courts within this tiny little geographic area. He can't influence much of anything outside of Fremont County. He tried to get me jailed for contempt on UPL allegations. I already know I won't do jail time, and I will win that battle. He can't influence all of the media (they are watching, I've interviewed with them, too), or all of law enforcement in Fremont County. Since he lost the election for DA by such an embarrassing margin to someone so new to law, it's clear he can't influence many of the people of Fremont County. He can't influence many from outside of Fremont County, either. He can't influence any of the higher courts. He's been exposed as nothing more than a bully who can only pick on those weaker than him. He can't take on anybody who is his equal. He can be beat, I've done it before. He can't influence me, no matter how dastardly his tactics are. He can't control me or my cameras or my broadcasts - that's why he had to make the incredibly stupid and desperate move to go after an innocent child in retaliation.

My influence includes a national grassroots movement and the court of public opinion worldwide. My overall credibility and authority are firmly established outside of Colorado. I have published more authoritative information on this issue than any other non-governmental entity in the country. Law professors have used my publications in their family law classes. My website gets over a quarter of a million hits a month from all over the world. I have several national and worldwide broadcast outlets for my programming. Media, lawyers, judges, legislators and others nationwide and in Canada come to me for authoritative and reliable information on this issue. Do the math before you decide.

Even if you decline to respond to me, your action or inaction will indicate your decision very clearly. I believe in free will. Yours, Meconi's, April's, everyone's. Whatever, happens, I'll be watching and the cameras will be rolling. I have nothing to lose, neither does April. If nothing else, I may come out of this with an award winning film that will have a profound impact in the court of public opinion in April's favor. You are a permanent member of the cast. You get to write your own part in the script. I'll see you in the movies.
