Letter of Admonition

Dear Mr. Kieffer:

At its meeting on October 8, 1993, the 11-member Colorado State Grievance Board (Board) reviewed the results of its inquiry in the complaint filed against you by Ms. Sheffer.

The Board found the testimony you provided in court warranted formal disciplinary action against your license to practice marriage and family therapy in Colorado.

In the opinion of the Board, there are reasonable grounds to believe you failed to meet the generally-accepted standards for the practice of marriage and family therapy and violated section 12-43-704(1)(g), C.R.S. Specifically, the Board determined that:

You testified falsely under oath about holding a faculty position in your court testimony.

The Board encourages you to review your professional code of ethics and the mental health licensing statute.

By this letter, the Board takes the formal disciplinary action of admonishing you for the conduct specified above.



In accordance with 12-.43-70S(3)(d), C.R.S.(1989). you have the right to make a written request to the Board to initiate formal disciplinary proceedings against your license to practice marriage and family therapy in order to adjudicate the conduct or acts upon which this letter is based. You must make your written request within twenty(20) days after receipt of this letter and address your request to Amos D. Martinez, Program Administrator, at the above letter head address. If you make a timely request, the Board will deem this letter of admonition vacated and may proceed with disciplinary proceedings in accordance with section 12-43-705(2), C.R.S.(1989), and applicable rules.

If this letter is not vacated, please be advised that a copy will be forwarded to the complainant and the Colorado Board of Marriage and Family Therapist Examiners for inclusion in your permanent licensure record upon expiration of the 20 day notice period cited above.
