<b>ORDER</b>	


This matter comes before the Court on Respondent's Motion for Reconsideration of May 4<sup>th</sup> Order in Light of Newly Discovered Evidence and for Disqualification of Bill Fyfe as Special Advocate. Having reviewed the Motion, the court file and the applicable legal authority, the Court enters the following Order.

The Court's Order of May 4, 2004 held that Respondent was to be responsible for fees "that [were] directly attributable to the Special Advocate's time spent reviewing documents submitted by Mr. Harrington." Order of May 4, 2004 at 1. Respondent filed a motion requesting reconsideration and disqualification of the Special Advocate on May 18, 2004. The Court denied this Motion on May 24, 2004. Respondent then filed this unverified Motion for Reconsideration on June 10, 2004 asserting the Court should reconsider its previous Order in light of newly discovered evidence. A motion under C.R.C.P. 59 must be brought within 15 days of the entry of judgment. C.R.C.P. 59(a). Defendant's Motion is outside the time-period of C.R.C.P. 59(a) and thus Defendant's new assertions in his Motion are DENIED as untimely.


