<b>FATHER'S EXHIBIT SUPPLEMENT TO C.R.C.P. 59 MOTION</b>	


Sean L. Harrington, father, submits the within EXHIBIT SUPPLEMENT TO MOTION FOR RECONSIDERATION PURSUANT TO RULE 59:

1. **Exhibit A** - July 19, 2005 email from Madeline Wilson to Christy Ryan, discussing that Wilson has started a “prayer chain” for the minor child and discussing Wilson’s experience in describing the instant case to her massage therapist (“Beth”) and passing on Beth’s advice to: “light candles and pray for Shelby to be bathed in a protecting light to keep her safe and take away all the bad stuff she has experience and seen in her ten years.”
  
2. **Exhibit B** - July 26, 2005 email from Madeline Wilson to Christy Ryan, incorporating an email from Madeline Wilson to Randy Dement. Among other things, the email contains Wilson’s admission to using the above-styled case (her client’s case) to pursue a personal vendetta against father. In her email to Dement, Wilson acknowledged that she was running afoul of the lawyer-as-witness rule.
  
3. **Exhibit C** - June 8, 2006 email from Madeline Wilson to Christy Ryan. In this message, Wilson describes a mysterious voice-mail she received from a woman she believes was an agent for father. She then advises mother to:

stop praying for him because that keeps you connected to him and that's not good. I would never have thought of that had someone not told me that specifically. I have released him to the Universe and hope you will too. Seriously, light candles, burn some incense and send his spirit away and do not speak of him any more.

The foregoing email exhibits were provided to father by mother.
