I have contacted you in the past eight months, see below for an email I mailed you in May (5/3) regarding Bailin being all pissed off at **my comments being on the web, and ordering them off**, one of which was the one you posted on your web site with my name, which was posted anonymously, and the website my friends put [REDACTED] I told you then I had to drop putting anything out there in public view to have any chance of getting my daughter back.

I have a court order in which Bailin says that because of that statement and the anonymous website the people at my church put up (which is down now because she ordered me to the last time I was in her courtroom), [REDACTED] I am scared to death what the price will be now if that blog stays up on your site.

Most of our case has been sealed; I don't know that you or anyone could get much information from the court records. Fyfe had it sealed as quickly as he could after the hearing. I don't think he wanted anyone to have access to what really happened. His is a game of smoke and mirrors and deception and corruption to the devastation of my and my children's lives. [REDACTED]

I appreciate it that you will consider taking my name off, but please don't use [REDACTED] Doe, that blog was posted under [REDACTED], and Fyfe and Bailin know that. The only way you could know my real name was my telling you so, which would be another sign to Bailin that I am refusing to do what she tells me. That blog had no identifying info on it. Fyfe is the one who found it and sent it to the judge, our PC (who promptly quit, and we now have no one overseeing our case still, a year later) [REDACTED]

[REDACTED] if Fyfe can get away with being so deceitful and dishonest, corrupt and just plain vicious, to fight him off we need to be very careful. He has friends in very high places, and a lot of money, and a lot of power, like it or not. And he is not afraid to use it to his own profit. You are battling an evil, wicked, corrupt and crooked man who will stop at nothing to shut us up, including ruining all of our lives. He could care less about us. I hope that you are not like him, not giving a crap about us either. Please, again I beg you, please take that blog with my name on it off.
