
Petitioner-Appellant, Bryan Spofford, representing himself in this matter provides the following Status Report as required by this Court's Order of March 30, 2006:

1. On June 12, 2006, Shari Yenni, Secretary to Gary L. Polidori, e-mailed Petitioner-Appellant giving notice that the trial court contacted her the prior week about setting a date for an evidentiary hearing.

2. At no time has the Petitioner-Appellant received any notice of action by the trial court regarding his November 17, 2005, motion requesting an evidentiary hearing on the matter of attorney fees.

3. On June 22, 2006, Respondent-Appellee issued a "Notice of Hearing Re Attorney Fees" for Friday, September 29, 2006, at 9:00 a.m. in Division 3 of the Jefferson County District Court.

4. Although Petitioner-Appellant previously requested a one-hour evidentiary hearing regarding two separate awards of attorney fees, the trial court communicated only with the Respondent-Appellee who, without any consultation with him, determined that Petitioner-Appellant's motion would require a two-hour hearing.


