



| <p>RESPONDENT-APPELLEE'S STATUS REPORT</p> | |

COMES NOW the Appellee, Lisa Spofford, by and through her attorneys of record, Polidori, Franklin, and Monahan, L.L.C., and provides the following Status Report:

1. In this Court's Order of March 30, 2006, the Court ordered Petitioner-Appellant to file a monthly Status Report which would update the Court as to the status of his November 17, 2005 Motion to the District Court requesting an evidentiary hearing as to attorney fees.
2. On July 28, 2006, Petitioner-Appellant filed a Status Report with the Court, as required by the Order of March 30, 2006.
3. Petitioner-Appellant correctly states in his Status Report that on November 17, 2005, he filed his Petitioner's Objection to Award of Attorneys Fees and Request for Evidentiary Hearing with the District Court requesting an evidentiary hearing on the matter of attorney fees. The only relief sought by Petitioner-Appellant in that Motion, was the scheduling of an evidentiary hearing on the issue of attorney fees.

4. In Petitioner-Appellant's Status Report, he alleges that the District Court has not ruled on his Motion. Respondent-Appellee denies this allegation.
5. The District Court has indeed ruled on Petitioner-Appellant's Motion. In fact, the District Court has set this matter for a two-hour hearing on September 29, 2006 at 9:00 a.m. in Division 3 of the Jefferson County District Court. Respondent-Appellee sent to Petitioner-Appellant a Notice of Hearing Re Attorney Fees on June 22, 2006. Why Petitioner-Appellee would claim that the District Court has failed to rule on his Motion to set this matter for an evidentiary hearing, is unknown.
