PETITIONER-APPELLANT'S STATUS REPORT		

Petitioner-Appellant, Bryan Spofford, representing himself in this matter provides the following Status Report as required by this Court's Order of March 30, 2006.

1. Petitioner-Appellant filed a motion with the trial court on November 17, 2005, requesting an evidentiary hearing on the matter of attorney fees. The trial court did not rule on this motion within 60 days, and Petitioner-Appellant filed an appeal.

2. The Court of Appeals ordered on March 30, 2006, that judicial economy would be served if Petitioner-Appellant amended his appeal of attorney fees after the trial court held his requested evidentiary hearing on the second award of attorney fees.
3. The trial court subsequently contacted the Respondent-Appellee regarding Petitioner-Appellant's motion for an evidentiary hearing, and on June 22, 2006, she issued a "Notice of Hearing Re Attorney Fees" for Friday, September 29, 2006, at 9:00 a.m. in Division 3 of the Jefferson County District Court.
4. Respondent-Appellee did not seek any input from Petitioner-Appellant about the time that he would need for his evidentiary hearing, and she unilaterally determined that two hours would be needed. Petitioner-Appellant believes that he will need only about thirty minutes, but he anticipates that the trial court will award attorney fees for the two hours determined by Respondent-Appellee in her Notice of Hearing Re Attorney Fees.
