
1. Case 2006CA299 was recertified, Petitioner-Appellant's Motion to Amend was granted, and this Court sent notice to Petitioner-Appellant on about February 2, 2007, that the record for 2006CA299 would be due in 30 days.
2. Most of the record designated in 2006CA299 overlaps with the record for 2007CA077, and Petitioner-Appellant has had difficulty in getting transcripts from Jefferson County District Court.
3. Of the four transcripts listed in his January 3, 2007, Motion to Amend, only one is present in the existing record. Although three requests for a transcript from October 23, 2002, were submitted between 2005 and 2007, Petitioner-Appellant first received notice on February 18, 2007, that the tape had been delivered to the transcriptionist.
4. Petitioner-Appellant previously paid another transcriptionist on August 19, 2004, and on May 6, 2005, for transcripts of hearings in June of 2004 and March of 2005, but both of these transcripts are currently missing from the record. On February 5, 2007, Petitioner-Appellant mailed a request for duplicate copies of these transcripts and asked the transcriptionist to contact him about payment. As of this date, he has not received an answer, and he plans to contact the chief transcriptionist again for help with getting copies of those two transcripts.

5. Petitioner-Appellant personally visited Jefferson County District Court in an attempt to facilitate the timely delivery of the records on appeal to this Court, and the appeals clerk suggested that he may need to request a ninety-day extension of the time to file the record.

Wherefore, Petitioner-Appellant respectfully requests that the Court:

- 1) permit sharing of the record for appeals 2006CA299 and 2007CA077, and*
- 2) grant a ninety-day extension of the time to file the record.*


