


1. That counsel for Petitioner wishes to withdraw as irreconcilable differences have developed between the attorney and the client.

  - c) That the Petitioner has the obligation to prepare for trial or any other hearing or hearings scheduled or to hire other counsel to prepare for such trial or hearings;

  - e) That if the Petitioner fails or refuses to meet these burdens, the Petitioner may suffer possible default;
  - f) That the withdrawal of counsel of record will not affect the progress or outcome of Petitioner's case;

h) That Petitioner has the right to object within fifteen (15) days of the date of this notice.
