<p><b>MOTION TO SET FOR STATUS CONFERENCE AND MOTION TO RULE/ORDER REPORT OF THERAPIST, CINDY DUCKWORTH PAID FOR</b></p>	

The Petitioner, Deborah A. Lohse, pro se, requests that this court immediately rule on her request for an order concerning the payment of the report held by Therapist, Cindy Duckworth and that the court set this matter for a Status Conference prior to the scheduled hearing, and

AS GROUNDS THEREFORE states as follows:

1. In my RESPONSE TO THERAPIST'S LETTER DATED MAY 20, 2002, I notified the court that Cindy Duckworth, MA, LPC, as former therapist for Dale K. Thorup, had prepared a report, the draft of which was dated May 13, 2002 for submission to the court. The report was not submitted to the court because payment had not been made to Ms. Duckworth for the report.
2. Ms. Duckworth informed the Petitioner that the report would not be released until her bill of \$720.00 for preparing the report was paid.
3. In my RESPONSE TO THERAPIST'S LETTER DATED MAY 20, 2002, I asked that the court order Respondent, Dale K. Thorup to pay the cost of that report so it could be released to the court and the parties. In the alternative, I offered to pay for half of the cost of the report, with the court ordering the other half paid for by the Respondent so that it could be released. I further stated that if the court found the report helpful that it order reimbursement to me from Dale Thorup for my half of the cost of the report.
4. As I have recently said in my RESPONSE TO MOTION TO VACATE JUDGMENT AS TO PARENTING PLAN AND REPLY TO RESPONSE TO PETITIONER'S PLEADING OF MAY 20, 2002, I think the report is critical to the court's ability to make a wise decision concerning best interest of our daughter, [redacted] Thorup, and whether or not the Respondent should be afforded unsupervised parenting time.
5. The Respondent, through his attorney has had the matter set for a hearing on August 27, 2002. If the court does not rule on my request for an order concerning payment for the report, the report will not be available prior to that hearing date and the court will be deprived of a very important piece of information in making its decision.

6. I also believe that a Status Conference held with the Judge prior to the hearing date would give direction to all of us, and perhaps even help us all with some of the issues ahead of time without the tremendous wait between now and the August hearing. [redacted] has not seen her father for quite some time and I believe it is important for her to see her father in a healthy setting, even if that is under supervision.
7. I ask the court to set this for a Status Conference as soon as possible, so that the court can give us direction and discuss further, if necessary, the need for the release of the report from Cindy Duckworth (please note that in my Response I have already filed with the court, I attached a draft copy of that May 13, 2002 report).

THEREFORE, I respectfully ask this court to rule on my request for an order directing which party or both of the parties shall pay for Ms. Duckworth's report, and that the court order this case be set for a Status Conference as soon as possible.
