

MOTION TO ORDER FULL DISCLOSURE BY PETITIONER AND PETITIONER'S ATTORNEY		

DALE KIM THORUP, Respondent appears pro se and respectfully requests at this time that the Court order the Petitioner and Petitioner's Attorney to make full disclosure to Respondent of all responses, motions, and pleadings filed with the Court by the Petitioner during the period November 6, 2002 to the present. Petitioner and Petitioner's Attorney have been advised that Respondent's Attorney, Roger Larsen filed a motion with the Court on November 6, 2002 to be withdrawn as the attorney of record for the Respondent. Pursuant to C.R.C.P. Rule 5, Mr. Larsen is no longer employed by nor an agent for the Respondent for the purposes of service, disclosure, and discovery in this civil case.

Respondent believes that Petitioner, through her Attorney, has submitted numerous filings with the Court during the aforementioned period and has neglected to properly serve Respondent with an accurate copy of same. Petitioner's failure to disclose said filings to the Respondent is wrongful and prejudicial toward Respondent's defense and, therefore, Respondent seeks expeditious relief from the Court. Respondent hereby affirms that he forwarded a request on December 2, 2002 to Petitioner's Attorney, by placing it in the United States mail postage prepaid, requesting that service be directed to Respondent directly at the above specified address. As of this date, Respondent's request for discovery has not been responded to by the Petitioner or Petitioner's Attorney.
